We understand the politics and pressures on Examiners in various art units and with various levels of seniority, and we are able to leverage this knowledge to more effectively advance prosecution. We also prefer to make use of Examiner Interviews, whether in-person or via video conference, early in the prosecution process to make clear to the Examiner the nature of the claimed invention, key differences from the art, and what scope of protection our clients require.
